- Proforma of the next audit on TV discussed and several amendments were made. The group has to create a new clinic policy proforma. The case note proforma will be the result of the alteration in the national TV audit forms. The updated forms will be circulated with the minute as a draft copy for further comments before the final forms get used.
- The group decided that every clinic needs to complete **one** clinic policy form and to complete case note forms of any patient diagnosed with TV in 2009 (minimum 10, maximum 20 per department). Departments with less than 10 cases, can go beyond 2009 (to 2008) to get cases.
