# Overview

## President's report

Working as BASHH President has been an incredible privilege over the last 12 months, meeting so many members, working closely with advocates, third sector agencies and cross sector colleagues has been a delight. I am prouder than ever to belong to this amazing group of carers, thinkers and doers.

I would like to thank my incredible colleagues, BASHH officers, BASHH board, special interest groups, including all those delivering guidelines and standards whether that be in administrative, analytical or delivery work- you have all contributed and the organisation goes from strength to strength because of you all. I would also like to express my deep thanks to past presidents and in particular Dr John McSorley, immediate past president for all his help and guidance and continued work.

When I took up the post of President, I set the organisation three goals, which I talked about at the president's dinner in March 2022 and in my address to members that month. Firstly, and crucially, I want to press ahead with widening participation and inclusion across the organisation. We have more nurses than ever delivering roles within sexual health services and we must include and empower nurse colleagues to set their own path and direction within the organisation. This began with changes at annual conference and some changes to nurse membership fees and conference attendance. The journey is only just beginning, and we must press ahead. The same must also be said for health advisers, an unsung and critical part of the sexual health workforce whose role has been incredibly challenging over the last decade – we support you and we must ensure we platform your critical skills and knowledge. The same must be said for Specialty (SAS) doctors- they are a critical backbone for delivery and again we must ensure they are platformed and supported and enabled to take on additional roles. I predict that the SAS role will become ever more important and perhaps we will see changes in the entire structure for training and specialisation. Broader engagement from specialty trainees, non-speciality doctors and medical students has increased immeasurably with the development of STASHH, (Student and trainee Association for Sexual Health and HIV). The inauguration of the Racially Minoritised Communities Special Interest Group has challenged the organisation to move forward where care still is inadequate and inequitable. We are incredibly grateful for the passion and commitment of the Chair Dwayne-Wilson Hunt and colleagues. This work must now press ahead.

Secondly, I wanted to increase the professionalisation of the organisation. We ask members and affiliates to commit a huge amount of time and work in what is effectively their own time. In days gone by this was possible and worked to the benefit of both the organisation, to those delivering and the wider membership. This is no longer sustainable and reduces diversity across the membership and diverse involvement in the organisation. My plan has been, with the agreement of board and the wider membership, to identify roles that BASHH can support financially. Currently there have been no roles receiving remuneration in BASHH, no payments made to trusts to ensure time in job plans including for president and officer roles- those most heavily time demanding. We have begun by approving funding for 2 hours per week for the Clinical Standards Unit lead and this will follow with 2 hours per week of paid time for the Clinical Effectiveness Group lead. We have approved a programme of delivery for the social and digital media work. M and F health have been contracted to increase our reach and influence via social media. We have a social media strategy which aims to increase exposure of BASHH and drive the organisations objectives across professionals, students, service users, patient groups and aligned organisations and charities. We have also approved a contract with a

medical writing company who will plan and co-ordinate delivery of clinical guidance, including the management of each guideline development, searching medical literature, referencing and working with the Clinical Effectiveness Group lead and lead writers to deliver guidance in a timely way. This has been co-ordinated by Professor Margaret Kingston and Dr Craig Tipple and is approved by board. We will continue to look for ways we can improve the efficiency of the organisation and support colleagues to deliver this valuable work.

The third goal I set was to improve visibility of the organisation at a political level, BASHH must drive the recognition of the valuable work we do as an organisation. In order to meet our core objectives, BASHH must raise awareness of the value of this work, describe the scope of care services currently can deliver and where the gaps exist, define them and seek redress. BASHH has worked with colleagues within the All-Party Parliamentary Group (APPG) for HIV and AIDS and M and F health on widening our reach with policy makers and politicians, more closely than ever before. This year we have led BASHHs first major event within the Houses of Parliament and House of Lords, an event regarding the impact of Mpox (formerly known as Monkeypox) on PrEP delivery. We aim to increase this over the next 12-24 months. Planning ahead, we will plan events focussing on *Prevention* and another on *Workforce*. Our aim is to draw attention the many gains for patients by improving access to sexual health services with evidence informed service planning and delivery of care. *Prevention* will focus on antimicrobial resistance, Access to PrEP, Vaccination delivery and service access. *Workforce* will look at the needs of patients, the range of service needs and ensure that we develop a workforce plan that can robustly sustain the workload we need to deliver.

In addition, we have had a very challenging year as an organisation and a group of professionals within sexual health services. Increasing demands on services and rising STIs with further reductions in public health grants, Mpox outbreaks across the world starting in London was incredibly challenging. The first cases of Mpox, identified by GUM physicians in May 2022, came without warning, as outbreaks often do. Many services had to dramatically change delivery, with incredible pressure being placed on services and colleagues. In order to ensure good access to Mpox assessment and later roll out of vaccine delivery, colleagues worked tirelessly. Nationally, BASHH officers attended hundreds of hours of meetings advocating for patients and services. BASHH collaborated with valued partners, across the sector including public health, commissioners of services, Terrence Higgins Trust, National AIDS trust and the Local Government Association. We worked with UKHSA and NHSE, to support their knowledge around the challenges of this outbreak. There are still challenges ahead with regard Mpox, vaccination delivery and wider STI outbreaks.

BASHH continue to use BASHH bitesize to engage with membership, commenced by Dr John McSorley during the COVID pandemic. The collaboration with IUSTI has been an incredible success and feedback regarding those events has been fantastic. The annual conference in 2022 in Sheffield, led by Dr Chris Ward was a fantastic success. Wider events delivery has been better than ever which we look forward to building on in 2023.

Alongside the organisations plan to widen participation, I have sought to engage with aligned professionals across the sector and ensure all 4 nations within BASHH regions have equal opportunity to be represented. This was emphasized when the Mpox operational group began with colleagues from all over the four UK nations contributing, sharing expertise and knowledge. It was this collaborative energy that we will continue to harness over the coming challenges and continue to deliver better support to members. We thank colleagues in OHID, STI liaison within UKHSA and wider networks that have helped support delivery over that last year. We are aware of the incredible work these groups deliver to support sexual health services and will continue to work closely with these organisations over the coming years.

Finally, I must thank all members for your incredible work and dedication, I look forward to another year of supporting and delivering for the interests of our members to enable improving services and care for our service users.

## Treasurer's report

### Financial Review

2020 was a financially challenging year for BASHH. As the result of COVID-19 lockdown, BASHH had to cancel all its training and educational events between February and September 2020. This has begun to be mitigated in 2021 through an increase of face to face activity and sponsorship. BASHH's income and expenditure have both increased in the year 2021-22.

As a result, BASHH made a surplus of £67,040.00 before net gains on investments (2021: surplus of £2,946 before net losses on investments) in the financial year ending on 31 July 2022.

Expenditure has increased from £476,564 in 2021 to £647,111.00 in 2022 due to a return to face-to-face events and workshops, with some increased support costs, as well as increased support during the Mpox outbreak.

Fixed asset investments performed less well in 21-22 than the year. The value decreased by £79,466.00, which overall brings BASHH to a deficit at year end of -£12,426 with a reported end funds of £1,932,414.

### Principal Funding Sources

Income for the charity comes from investments, membership subscriptions, and educational events. Because of the charity's stable financial position, there are no proposals to increase membership fees although this will be considered in the next financial year.

At 31 July 2022, the charity has total reserves of £1,932,414 (2021: £1,944,840). This comprised of £4,150 (2021: £4,150) restricted reserves, £10,000 (2021: £10,000) endowment fund, and £1,918,264 (2021: £1,930,690) unrestricted reserves. Unrestricted reserves have decreased by £12,426 for year ending 131st July 2022 (compared to an increase of £248,180 in 2021).

Other Groups within BASHH feed into this committee: The Clinical Effectiveness Group, the Clinical Standards Unit (CSU), the National Audit Group (NAG), and the BASHH/FSRH Integrated Information Group.

- To oversee, set and monitor standards and specifications relating to BASHH
- To identify areas of best clinical practice and promote their adoption whilst recognising local variation in capacity, infrastructure and policy
- To identify regional and individual clinic difficulties and support such services to explore solutions to issues, mobilise support and suggest action plans.

## Significant activities/ Outputs 2021-2022

- The CGC met 4 times, 3 virtual and one face to face during Sheffield Spring conference.
- Prior to COVID-19 all meetings were face to face, on discussion with member's, agreement made to continue with virtual meetings and one face to face meeting during the Spring conference. This will hopefully reduce time burden on participants
- During meetings several governance problems discussed such as drug shortages, workforce issues, COVID-19 recovery and Mpox
- In addition to meeting there is a WhatsApp channel which is used to disseminate information quickly to members
- The CGC has developed Roles and Responsibilities for branch chairs and representatives with expected time required.
- The CGC is developing guidance with the Education Committee for chairs and representatives on how to organise meetings
- Funding for regional meeting continuing professional development (CPD) is now supported by BASHH
- The CGC has been an effective ongoing channel to disseminate intelligence and information between BASHH and its members rapidly on issues such as COVID-19 recovery, Mpox outbreak etc
- Ongoing development of contact details for each clinic

## Future plans

- To support BASHH's commitment to equitable geographical provision of on-line services that support high standard face to face sexual health services
- To support BASHH to lead on the development of coherent holistic sexual health strategies for all four nations in the UK

- To provide training to all representatives on managing funds by BASHH Treasurer
- To support BASHH in assessing senior workforce numbers

The Education Committee is responsible for facilitating the delivery of the BASHH's vision, values and service priorities through education, training and development. The Educational committee (EC) and Special Interest Groups (SIGs) develop and maintain educational programmes providing high levels of specialist training and skill, whilst embracing a wider, more integrated sexual health remit across a wide geographical area and range of healthcare settings.

The COVID-19 pandemic brought new challenges in delivering education and training and our members have continued to adapt to teaching online ensuring that events are interactive and inclusive. We have started to

arrange more in-person events again this year as well as hybrid events while recognising the benefits in terms of accessibility of virtual meetings.

### **The Special interest groups (SIGs)**

The SIGs lead on the development of educational materials and meetings within their specialist areas. They develop and deliver educational programmes and courses. They also contribute to education and training by generating publications and research, developing guidelines and recommendations in collaboration with other BASHH groups and external organisations, and reviewing and responding to documents on behalf of BASHH. Individual reports detailing specific contributions are available within the BASHH Annual Review.

This year the SIGs provided several well-established courses online, hybrid and in person such as Genital dermatology, SAS Doctors conference, HIV masterclasses and the Diplomas in GUM and HIV revision courses. A new Racially Minoritised Communities SIG has been established in the past year and has already been very productive contributing to several projects and leading a symposium at the spring conference.

Our trainee representative Dr Ellie Crook has continued to lead the Student and Trainee Association for Sexual Health and HIV (STASHH) to great achievement. STASHH was formed to improve recruitment to Sexual Health & HIV medicine by facilitating clinical & academic opportunities for medical students & Pre-specialty Trainees. They have membership from the majority of medical schools and deaneries and put on monthly webinars and also contributed to the Spring conference.

### **BASHH scientific meetings**

The EC is responsible for providing regular Scientific meetings (BSM) which are free to BASHH Members. SIGs take it in turn to organise these meetings and they often take a two-part structure, organised by two individual SIGs. They have mostly been held virtually over the past year with one hybrid meeting in March with excellent attendance figures and good audience participation via chat.

In July 2021 there was a BASHH symposium at the online ISSTDR/IUSTI led by the NATSAL team. The virtual BASHH 2021 conference replaced the autumn BSM.

The January meeting was led by the dermatology and HIV/BBV SIGs with Prof Kevin Fenton receiving an Honorary Life Fellow Award and bringing the virtual house down with a truly inspiring speech. March saw our inaugural hybrid BSM with the Bacterial SIG and Public Health England informing and entertaining audiences both at the Royal Society of Medicine and many more around the UK and beyond on Zoom. Podcasts/webcasts of the lectures are available on the BASHH website for members to access in their own time if they were unable to attend the meeting.

### **Scholarships, Fellowships and Travel awards**

The Education Committee continued to support the BASHH Educational Fellowships previously awarded to Drs Jesal Gohil, Natasha Bell, Joseph Heskin, Katie Humphries, Sophie Ross and Claire Pritchard. Dr Su Currie and Dr Katia Prime from the Prison SIG are supervising the 6 projects with help from UKHSA and other members of the Prison SIG. They will present their work at an upcoming BSM.

The Undergraduate Essay prize winners were Angharad Rose and Kathleen Rafferty and prizes were presented at the spring conference.

We look forward to ever more ingenious and exciting educational events in 2022-3 be they virtual, in person or hybrid.

### **Objectives:**

- To recommend strategies for IT implementation, data collection and reporting for the spectrum of Sexual Health services (ranging from non-integrated services to fully integrated services).
- To liaise between DHSC, HSCIC, UKHSA and other agencies regarding information issues to achieve best outcomes for both patients, the public and public health.
- To advise on the type, quality and format of information to be collected from Sexual Health services for the purposes of national audit, public health monitoring and monitoring of service performance.
- To respond to relevant consultations affecting service provision, data collection and information governance in Sexual Health.
- To receive and respond to queries and concerns from members relating to IT and Information Governance, including data protection and confidentiality rules.
- To anticipate issues relating to IT and Information Governance from new legislation, commissioning or other changes that affect Sexual Health.
- To disseminate important information to BASHH/FSRH members via organisational websites/newsletters.

### **Significant activities & Outputs in the year 2021-2022**

- The Group met on 3 occasions during 2021-22
- The Group responded to the Mpox virus outbreak by liaison with services and UKHSA to develop and rapidly deploy intuitive and practical Mpox activity and diagnostic codes: these pave the way for accurate capture of epidemiology data, vaccine roll-out, but also service provision that can be aligned with tariff algorithms.
- The Group advised UKHSA around the messaging and communications with services regarding use of patient identifying information (PII) on Mpox laboratory request documents in order to patients' wider sexual health status and tests.
- The Group have advised DHSC on the further reworking of the consensus statement for confidentiality in Sexual Health Services (following the lapse of the NHS STI regulations).

- The Group advised UKHSA on the development of patient information leaflets which detail how their personal data is managed both within services and when anonymised for national surveillance reporting.
- The Group reviewed the Scottish tissue and cells donation service (TCAT) and considered issues of confidentiality and information governance relating to sexual health patients and services. This culminated in a set of best practice recommendations produced by the joint information group and submitted to TCAT.
- The Group have responded to numerous questions posed by BASHH members regarding data management, information governance and statutory reporting for sexual health services.
- The Group have considered matters of relevance to GUM Clinics, SRH clinics and Integrated Services in relation to statutory reporting including GUMCAD, SRHAD and HARS.
- The Group have advised UKHSA on matters arising including GUMCAD and HARS
- The Sexual Health – EPR (Electronic Patient Record) working group has continued to develop the standardised specification for EPR and launched a national survey to evaluate sexual healthcare practitioners' experience of EPR systems.

### **Future plans**

- To continue to work closely with members of the FSRH, National Institute for Health Protection, UKHSA, DHSC, NHS Digital, software providers and others to ensure that we meet our objectives.
- To ensure the objectives and benefits of this Group incorporate relevant issues for all devolved nations of the UK.
- To be both pro-active and responsive to upcoming matters that affect data handling and Information Governance to produce and disseminate best practice advice to BASHH & FSRH members.
- To progress work on developing a comprehensive standard EPR specification and engage with all stakeholders to promote and iteratively develop it.

### **Objectives**

- To produce the BASHH guidelines for the management of sexually transmitted infections & related conditions
- To produce patient information leaflets to support application of the guidelines.
- To liaise with internal and external key stakeholders including the British HIV Association (BHIVA), the Faculty of Sexual and Reproductive Health (FSRH), The Medicines and Healthcare products Regulatory Agency, the BASHH Audit Group and the BASHH Public panel.

### **Significant activities**

- Ongoing review of the current BASHH guidelines and patient information leaflets, production of updates and of new guidelines. - BASHH has been a NICE accredited guideline producer since the scheme was introduced. In 2021 we achieved full re-accreditation. This year NICE have informed us of their intention to stop this accreditation scheme.

- Ongoing liaison with stakeholders

## **Revalidation Group**

### **Objectives**

- To provide specialty-based advice and support to the RCP revalidation team
- To provide support for BASHH members in matters related to revalidation
- To develop specialty specific guidance to support members wishing to revalidate
- To ensure that the specialty specific advice is kept updated and remains current

### **Significant activities**

- Specialty specific advice available on to the BASHH website and the RCP revalidation section
- Supporting the RCP to develop specialty specific clinical outcomes

### **Performance/Outputs in the year 2021-22**

- In April 2022 the GMC gave an update on revalidation for doctors and changes to the notice period in view of the on-going pressures on the profession and the health services and that the impact of the COVID-19 pandemic will be felt for a long time.
- In order to support doctors to prepare for revalidation, the GMC is extending the routine notice period given ahead of their submission date from four to 12 months. The change will give responsible officers

the flexibility to submit a recommendation to revalidate a doctor up to 12 months before their submission date and support doctors to revalidate when they are ready.

- Appraisal remains an important foundation stone of revalidation and the GMC expect it to take place annually.
- In June 2022 the Academy of Medical Royal Colleges introduced the Medical Appraisal Guide 2022 (MAG 2022). It replaces the 'Appraisal 2020' process created for the flexible restart of appraisals during COVID-19.
- It builds on the successes of Appraisal 2020, but no longer focuses on the pandemic – instead asking what the impact of the period since the last appraisal has been. In response to what doctors said they valued, it is a return to a more formative and developmental discussion, with less documentary requirements, and an opportunity to talk about health and wellbeing if they wish.
- The GMC has confirmed that these appraisals are consistent with existing GMC guidance for appraisal and revalidation.

#### **Relevant questions and answers on the GMC website are:**

***Will I have to make up any missed appraisals before my responsible officer can make a revalidate recommendation?***

- *No. While appraisals should normally be annual, you don't have to catch up on an appraisal if there is a legitimate reason for missing it. This includes the pandemic.*

***Do I need to do anything differently because of the change to revalidation notice periods?***

- *No. You should continue to engage as normal, by collecting the required supporting information and reflecting on it at your annual appraisals. When you are ready to revalidate and your responsible officer has reviewed the information required to make a recommendation, they will submit it to us by your submission date.*

***What revalidation date will I be given when I revalidate?***

- *When we approve your responsible officer's recommendation, you will be given a new revalidation date five years from the date of your previous revalidation date. This will have the effect of extending your next revalidation cycle if you revalidate early in your notice period.*

***What if I'm not ready to revalidate?***

- *Your responsible officer can submit a deferral recommendation if you've not been able to collect all of the required supporting information and discuss it at an appraisal. A deferral simply postpones your revalidation date; it has no impact on your licence to practise. It does not reflect any concern about your practice or professionalism.*

- Work continued to raise awareness of the Position statement on Inappropriate use of Multiplex testing platforms and suboptimal use of antibiotic treatment regimens, previously published on the [BASHH website](#). It is ongoing within the work streams; Core group (with oversight of all work streams), Guidance and Standards, Evidence, Patient and Public engagement, Political engagement and Dialogue with services.
- The statement was introduced and discussed at a BASHH Bitesize session in February 2022. The background was given by Dr Suneeta Soni, and then a series of short presentations were given by Dr Ellie Clarke (Online testing providers), Dr Liz Okecha (Online pharmacies), Dr Achyuta Nori (CEG guidance), Simon Whaley (Political engagement) and was concluded with a panel discussion on next steps.
- Dr Emma Harding-Esch gave a presentation entitled 'Ensuring safe and quality patient care in the era of online testing and treatment providers for sexually transmitted infections in Great Britain' at the Julius Schachter International Symposium on Human Chlamydial Infections in June 2022.
- Two manuscripts were accepted for publication.
  - Clarke E, Horner PJ, Muir P, *et al* Assessment of online self-testing and self-sampling service providers for sexually transmitted infections against national standards in the UK in 2020 *Sexually Transmitted Infections* Published Online First: 12 April 2022. doi: 10.1136/sextrans-2021-055318

- Publication of the updated Position statement on Doxycycline as Prophylaxis for Sexually Transmitted Infections in November 2021 and subsequent work to raise awareness of the recommendations:
  - Session delivered by Drs Suneeta Soni and John Saunders on STI prophylaxis at the STI Journal symposium during BASHH annual conference 2022 in June.
  - Publication of BASHH column in STI journal highlighting the updated position statement: Kohli M, Medland N, Fifer H, Saunders J. BASHH updated position statement on doxycycline as prophylaxis for sexually transmitted infections. *Sexually Transmitted Infections* 2022;98:235-236.
- The BSIG delivered a session at the October 2021 virtual BASHH conference. It was chaired by Dr Emma Harding-Esch with contributions from Dr John Saunders (Update on the new NCSP) and Rachel Pitt (Homotypic/genotypic AMR and chlamydia) followed by a debate 'Abandoning the two-week window period for testing for Chlamydia'. Dr Paddy Horner spoke for and Dr Achyuta Nori spoke against the motion.
- A session entitled 'Hot Topics in STIs' was delivered at the Federation of Infection Society (FIS) in November 2021 on behalf of BASHH. It was chaired by Professor Catherine Ison and included talks by Professor Jonathan Ross (Gonorrhoea resistance and an update on management approaches), Dr Achyuta Nori (Syphilis masquerading as malignancy), Dr Helen Fifer (Congenital syphilis: an update) and Dr Mike Rayment (Treatment challenges in symptomatic *Mycoplasma genitalium* infection). FIS targets infectious disease consultants outside the STI speciality. There were 243 people online.
- The BASHH scientific meeting in March 2022 was organised jointly between the BSIG and UKHSA. The BSIG session was organised and chaired by Dr Achyuta Nori with contributions from Dr Kate Nambiar (Non-candida vaginitis), Dr Daniel Richardson (Multi-drug resistant *Shigella spp.*) and Dr Helen Fifer (Disseminated gonococcal infections and Multi-drug resistant gonorrhoea). The BSIG website and App on Microscopy of STIs was formally launched by Professor Catherine Ison and Dr Frances Keane and is now available through the BASHH website and can be accessed through a browser (website: bsigmicro.org) or Apple App store/Playstore for tablet or phone (bsigmicro App). The first quarter shows the total website users were 2546 and there were 182 App downloads (49 Android, 133 Apple)
- Continual review and updating of the [Bacterial SIG webpage](#) with links to the Position statements.
- The Microscopy course has not restarted since the pandemic. Re-organisation to identify a suitable format and venue for any face to face teaching was discussed and is ongoing

### Future plans

- Transfer of the chair of the BSIG will take place in March 2023.
- Continue to raise awareness of issues raised in both Position statements.
- Arrange meetings to follow up with key stakeholders and prepare clear options appraisal about key pieces of work around delivery of the Position statement on inappropriate testing platforms and treatment of STIs.
- Explore embedding a question about use of antimicrobial treatment for STI prophylaxis into routine consultations and consider an audit.
- Contribute to scientific sessions at various meetings including Federation of Infection Society and IUSTI Europe in September 2022.
- Publication of BASHH column on BSIG activities.

- Continue ongoing discussions with the STI Foundation course to explore producing competencies for Microscopy for STIs.
- Further promotion of the BSIG website/App will continue, particularly for teaching purposes.

### Objectives

The Joint Specialty Committee (JSC) for Genitourinary Medicine (GUM) acts as an advisory body to the Royal College of Physicians (RCP) on matters concerning sexual health and HIV. It meets twice a year and has a membership drawn from both the RCP and BASHH. There is usually representation from the RCP's Patient and Carer Network but recruitment to the two vacant posts was paused due to the COVID-19 pandemic.

### Significant activities

- The Committee has met virtually using an online platform with meetings in December 2021 and June 2022.
- Interim discussions between scheduled meetings have taken place.

### Performance/Outputs in the year 2021-22

- The Committee has ensured that the RCP is fully advised about the issues affecting the specialty, including workforce planning and training, and the commissioning and tendering of HIV and sexual health services.
- The Committee has updated the RCP on standards that were relevant to GUM including those produced by NICE, BASHH and the FSRH.
- The Committee has responded to a wide range of national consultations.
- A proposal to change the name of the specialty from 'GU Medicine' to 'Sexual Health and HIV Medicine' has been submitted to the RCP.

## **Future Plans**

The Committee will:

- Continue to ensure that issues of importance to the speciality are raised with the RCP.
- Seek to recruit representation from the RCP's Patient and Carer Network and a trainee representative.
- Work to ensure training and workforce planning issues are addressed.

## **Specialist Advisory Committee**

### **Significant activities & performance Outputs 2021-22**

#### **Curriculum**

- Current trainees are transitioning to the new curriculum; joint GUM and Internal Medicine Training, which is now mandatory for all newly recruited trainees from August 2022.
- Individual training needs are being discussed and documented at the trainee's next ARCP. Extensions to training will be planned and supported if needed.
- Internal Medicine (IM) ARCPs are to start for those on the new curriculum from June 2023 with local arrangements regarding separate IM ARCPs or IM assessor on GUM panels (this will be the case in London).
- A GUM rough guide has been produced to support the curriculum.
- A syllabus has been developed to aid with DipGUM & DipHIV exam blueprinting.
- A post curriculum implementation questionnaire is being developed.
- The co-chairs attend all national training days and provide workshops at all specialty national conferences to ensure the specialty is well briefed on the new curriculum and have question and answer opportunities.
- The Diplomas we require for the curriculum – the DipGUM and DipHIV have now had the written and OSCE elements un-coupled, so trainees do not necessarily need to pass them at the same sitting, but within 2 years of each other.

#### **Workforce & recruitment**

- Health Education England (HEE) are undertaking a workforce review of all training numbers with a view to re-distributing training numbers as they become vacant from inside London to elsewhere. GUM is due to be considered in 2029 which is good news as this will allow time for the transition to the new curriculum to occur.
- We remain very concerned about the high number of vacant posts and the fact that we have an uneven distribution of STIs/HIV and existing consultants and hence training opportunities. The workforce team have looked at population mapped to STI/HIV hot spots plus snapshot of current consultants and trainees which we hope will inform the HEE review. We are working closely with the JRCPTB on this.

#### **Promotion of the specialty**

- Working with BASHH conference & media team, and the "Eagles and Sparrows" leadership course regarding the "Love GUM" project.

- Trainee educational fellowship for 2 years running to support this mentored by SAC co-chair Margaret Kingston.
- Working closely with STASHH to improve profile, opportunities and mentorship for medical students and trainees interested in a career in GUM.

### **Succession planning**

- The co-chairs demit this coming year after 6 years in post. We have been the first co-chairs of a SAC and we have found this model to work extremely well, especially with one of us from London and one from the provinces and we hope we have established a precedent for our SAC and for others.
- Invitations to apply for the SAC chair will be extended early in 2023 to SAC members as per the JRCPTB process.

### **Workforce report**

- Thank you to Ashini Fox who has stepped down as deputy workforce officer at the end of 2021 and to Imali Fernando who has now taken on the role.
- In 2021, 33 permanent consultant posts advertised– all for a mix of GUM or integrated sexual health with an HIV component. 20 were advertised as full-time posts. 1 post (Jersey) has been advertised 3 times. In addition, in 2021, 29 locum posts (15 full-time) were advertised, the majority for 12 months.
- This is a significant increase compared with 2020 when 26 substantive posts were advertised (12 fulltime) and 18 locum posts. It is similar to 2019, pre COVID-19 when 32 substantive posts were advertised. In the first 7 months of 2022 23 permanent posts and 13 locums have been advertised.
- The current rate of consultant posts being advertised is now beginning to exceed the number of trainees gaining their CCT, although most posts are reported as being filled at present. It remains to be seen how supply and demand will be matched with the impending change to training with dual accreditation, the impact of the low fill rate of training posts in the last 2 years and the upcoming changes to sexual health commissioning. This challenge has been highlighted to the JRCPTB and HEE and a couple of workshops have taken place.
- There have been major changes in the RCP workforce unit and the usual annual meeting did not take place in November 2021. The annual consultant survey for 2020 had a very low return rate of 27% making interpretation difficult. There were 491 (122 part-times) consultants working in Integrated Sexual Health/HIV of whom 332 were female. 440 worked in England, 11 in Northern Ireland, 23 in Scotland and 17 in Wales.
